Summer Season's Skating Pass

Liability Release, Acknowledgement of Risks and Hazards, And Agreement Not To Sue

PLEASE READ CAREFULLY. THIS IS A LEGAL DOCUMENT.

WARNING: Use of Sunrise Rollerland facilities and/or equipment, including Roller Skating, Inline Skating, and other recreational activities is HAZARDOUS. Falls and injuries are a common occurrence and you must keep deliberate and conscious control on the skating floor. You must participate in activities only within your own ability. Your safety and that of others is directly affected by your judgment. Be alert to all risks, hazards and dangers while skating; collisions with other participants or other persons (whether as a result of failure to roller or inline skate or participate in these activities within their own ability or otherwise) or collisions with any of the risks included in this paragraph (whether natural or man-made).

1. In consideration of being permitted to use the Sunrise Rollerland facility, I agree to RELEASE, INDEMNIFY, DEFEND AND HOLD HARMLESS Sunrise Recreation Corporation, Sunrise Rollerland and affiliated companies, their respective agents, officers, directors, owners, contractors, volunteers, employees and insurers (collectively, the "Released Parties") from any and all claims I might bring as a result of physical injury, including death, or property damage sustained in connection with my use of Sunrise Rollerland facilities INCLUDING CLAIMS BASED ON NEGLIGENCE OR BREACH OF WARRANTY. I am fully aware of and accept all risks, hazards and dangers associated with using the Released Parties facilities and I am fully responsible for any and all damage or injury of any kind that may result from my use of the Released Parties facilities. I promise not to bring a claim against or sue the Released Parties and agree that if anyone is physically injured or property is damaged while I am using the Released Parties facilities, I will have no right to make a claim or file a lawsuit against the Released Parties. I also agree to indemnify and defend the Released Parties for any and all claims, including subrogation and/or derivative claims, brought by any third party or insurer, for injury or damage I may cause.

2. Applicant will be issued a Season Pass by mail when form and payments are complete. Applicant agrees to (a) check in at the front desk; (b) present the Pass to any Sunrise Rollerland authorized representative upon request; and (c) refrain from reckless skating or participating in conduct that is not consistent with safe and prudent skating, violates "Your Responsibility Code" or the law, acknowledging that the Pass may thereafter be revoked without refund. The Pass is not transferable and not refundable. In the event the Pass is lost, stolen or unrecognizable, you must pay a non-refundable fee of \$10 for any replacement pass. The Pass expires on August 31st, 2009 or September 30th 2009 and may have other restrictions. This Pass is never valid Friday Nights, or for Morning Adult Sessions. Competitive Skaters registered with USA Rollersports may not purchase this pass.

3. In consideration of the Released Parties use, I hereby grant permission to and release the Released Parties to use my image(s), name, biography, voice, picture or other likeness(es), whether video, digital, or print (collectively, "image"), for commercial purposes or otherwise including advertising, publicity, public relations and editorial use, without restriction as to frequency, duration or medium.

I HAVE CAREFULLY READ THIS IMPORTANT DOCUMENT AND FULLY UNDERSTAND ITS CONTENTS. I agree that this is a Release of Liability and Agreement Not to Sue, which will legally prevent me, or any other person, from filing suit or making any other claims for damages in the event of personal injury, death or property damage. I freely and voluntarily enter into this agreement. I understand that permission to use the resorts, their facilities, premises and equipment is being given to the undersigned participant in exchange for the execution of this Liability Release and Promise Not to Sue. I have made no misrepresentations to the Released Parties regarding my name, age or any other information. I intend this document to be interpreted as broadly as permissible by California law.
